CCSO Timeline

1995: Tyler joins LEO employment at 19-years-old - she was known as the first "female deputy to look like a female" in OK by her peers - she noted that it was hard to get people to take her seriously. The sentiments there were that "Women only belong in Law Enforcement(LE) to take out the trash."

1998: Sheriff Burnett starts his career with the CCSO

May 1, 2003: Custer County Sheriff Burgess gropes Tyler as she tries on uniform pants before her first day of work as a Sheriff's Deputy for Custer County - he was 50 she was 27. This harassment continues through her employment at this office.

May 17, 2004: Deputy Aaron Seabright is hired by the CCSO

2005: Deputy Tyler is asked to apply at the CCSO and does a ride along - Tyler accepts invitation to apply after she believes the work environment will be better.

Aug 2006: Deputy Tyler is hired by the CCSO under Sheriff Harum - moves 2,000 miles to get away from harassment in OK - she is immediately offered two call sign numbers and only two, though there were others available at the time - K63 or K69. K63 was the call sign of a deputy that committed suicide with his service weapon. It is tradition to retire call signs when an officer is killed in the line of duty, but a suicide was not considered "something reputable" to die of so it was not retired. The service weapon used by the deputy to end his life was also kept in circulation. Tyler had two untenable options infront of her: debase herself and publicly be considered the sex call sign as a minority deputy(and never be taken seriously) in the department or retraumatize the mother of the deputy who worked in juvenile services and would potentially come across the call sign in reports. Tyler chose K63. She soon finds out that the CCSO was being "sued by a woman" and the reason she was hired was solely because it would look better to hire a woman to add to the perception that they weren't discriminatory.

April 2008: Sheriff Burgess in OK is accused of raping inmates with a flashlight - Tyler declines to testify but helps them locate a key piece of evidence -the flashlight used on the inmates - soon after the flashlight goes missing from the Custer County Sheriff's evidence room - Tyler agrees to testify because without that evidence the prosecutors told her Burgess would walk

January 2009: Tyler takes leave and quietly testifies against Burgess as a victim in the trial and also as the arresting officer of some of the women attacked. She did not directly tell her superiors what she was doing in order to keep her name out of the press - she knows that testifying against a fellow LEO, even criminals like Burgess, is considered crossing the thin blue line and could get her harassment at the CCSO - Tyler receives a call from a peer deputy at the CCSO asking if she's in OK testifying at a trial, they had heard about the trial and her name linked to it.

Tyler knew it was possible she would be committing "career suicide" by doing the right thing, but she says she couldn't have "lived with herself if she didn't testify".

Mar 24, 2009: Burgess gets 79 years in prison and convicted of 13 felony counts

March 2009: When Tyler returns from the trial, the work environment takes a steep turn for the worse. For the most part over the previous three years at the CCSO, Tyler had been able to foster great working relationships with her peers. Suddenly, no one would talk to her and her working conditions became untenable.

May 2010: One year after Burgess's conviction the missing flashlight from the criminal trial is found in the Custer County Sheriff's Office evidence room during a second civil trial - it tested positive for sets of DNA - Tyler is compelled by the prosecution to testify at the civil trial in which she had refused - Tyler declined any settlement as she did not want to testify.

November 2010: Sheriff Harum fired Tyler claiming she was being "untruthful in obtaining an email during a disagreement" with a supervisor.

November 02, 2010: Sheriff Harum loses election to Brian Burnett

2011: Undersheriff Wisemore signs a document that all weapons are accounted for in the Armory

Dec 20, 2011: Grace City Church then Grace Covenant Church operating out of the Free Methodist(Free Meth) church begins planting their church, uploads their first video to YouTube. Though according to a later ground breaking date they started in 2008.

2012: Fully automatic M16 goes missing from the CCSO department's armory - reported to supervisors by the person responsible for inventory- Sgt Mike Harris

2013: Deputy Aaron Shepard joins the CCSO

March 2013: An arbitrator found "no just cause" to fire Tyler

Early May 2013: An M16 goes missing from the the Grant County Sheriff's Office Armory

May 2013: An M16 goes missing from the East Wenatchee Police Department but was later found after an extensive search in a locker not normally used to store weapons

End of May 2013: Tyler rejoins the CCSO

Aug 2013: Sgt Harris opens official investigation into missing M16

Dec 2013: Tyler files suit against the CCSO for retaliation specifically against the Burnett administration and Burnett himself when he declined to allow Tyler her original night shift so she could be home during the day with her disabled daughter. The lawsuit was also on the grounds that she was mistreated by him and her co-workers after her court testimony in 2008, which helped convict the Custer County sheriff. The mistreatment continued and worsened after she returned under the leadership of Burnett 7 months prior.

Soon after announcing the lawsuit a new CCSO deputy was hired: Deputy Danne Dunlap.

2014: Undersheriff John Wisemore tells the Army that the missing M16 was "nonfunctional and had been destroyed" - Mike Morrison is "forced" to be Jennifer Tyler's partner as the deputies were "shunning" her

Jan 2014: Sgt Harris completes missing weapon investigation and reports that he found no evidence of a log that the weapon was nonfunctional or destroyed. This report by Harris led the US Dept of Defense to suspend the CCSO from the 1033 program which allowed local LEO agencies to request military-grade weapons, vehicles, and armor at little to no cost.

Feb 5, 2014: As a drug recognition expert and instructor since 1998-1999, Harris requested new drugs be supplied for teaching a drug class - Wisemore began an investigation into Harris' intended use for the drugs

Feb 18, 2014: In a meeting with both Burnett and Wisemore, Harris was informed they thought he was lying about the intended use for the drugs and that he would use them for his personal drug teaching business which was against policy. At this time they threatened to demote him from chief of patrol or ask him to resign and keep his rank.

Feb 26, 2014: Harris took the demotion and resigned as chief of patrol effective Mar 1, 2014 - though there was no internal investigation nor a determination made Burnett placed Harris on the Brady list at that time. This is a list of LEOs in which their credibility is called into question were he ever to testify in court... for anything. This status was later publicly reported in local newspapers - defaming Harris.

At some point in 2014 Deputy Jennifer Tyler was also arbitrarily added to the Brady list for alleged "untruthfulness", even though Harum, in the arbitration that exonerated her before reinstatement in 2013, stated that her actions in 2010 did not qualify as Brady material.

June 6, 2014: Deputy Carl Mohns handed his personal firearm, a 380-caliber semi-automatic, to Deputy Lee Risdon, "who had also been consuming alcohol," according to Chelan County Sheriff's records. Risdon then took the gun, got down on the ground, put it into the swimming pool, and fired. Eight-to-10 people gathered around and cheered. Deputy Dan McCue was also in the crowd, allowing and encouraging this behavior. All three were not formally reprimanded until one year later, after the incident was made public. The three deputies disputed the reprimands.

Sept 9, 2014: Undersheriff Wisemore repeats the unfounded information that the M16 was "probably" destroyed to local newspapers.

Nov 2014: The CCSO began alleging "untruthfulness" against Harris and violations of overtime violations. An investigation was launched.

Nov 2014: Deputy Shepard was certified in K9 handling with K9 Reno.

2015: After patrolling with Tyler for a year, Mike Morrison actively applies to have her for a partner, seeing that she was a good asset to the Department

Jan 2015: Harris was placed on administrative leave

Feb 2015: A Loudermill hearing, an internal required process that must be provided to public employees prior to removing or impacting their employment rights, was conducted for Harris.

Feb 26, 2015: Musgrove named Dpty of the year for 2014

Mar 20, 2015: A second hearing was held for Harris and that internal process determined that Harris violated policies

Mar 31, 2015: Harris was terminated from the CCSO - Burnett stated it was because Harris lied in email requests for drug samples from the CCSO evidence department and alleged violations of overtime rules - an arbitrator later ruled the department had no just cause for the firing and reinstated him in 2016.

June 17, 2015: Grace City Church buys a plot of land to plant their church for \$765,000

Aug 19, 2015: Sgt Zimmerman and then Deputy Musgrove filed a formal complaint against Deputy Jennifer Tyler stating that she did not say "Hi" to them or return a greeting. Musgrove specifically said that Tyler issued a "look of disgust" at Zimmerman. After constant comments and sexual harassment from her peers, talking about how she looked, her butt, and any aspect of her body they felt like for years and under three different Sheriffs: these two LEOs thought that because she didn't acknowledge them, it was worth of a formal complaint.

Dec 15, 2015: Deputy Shepard was awarded the Proactive Traffic award at the Night of 1000 stars

2016: Mike Morrison was blocked from requesting Tyler as a partner do to some new K9 policy: Tyler was assigned to Aaron Shepard - Deputy Aaron Shepard leaves Grace City Church

Feb 2016: Sgt Harris is reinstated to the CCSO after an independent arbitration hearing determined there was no just cause to fire Harris

Mar 9, 2016: Detective Carlos Rodriguez negligently hits and kills his K9 partner, Reefer

March 10-17, 2016: Undersheriff Jason Mathews fails to tell the whole truth and misleads the public by saying Reefer the K9 was hit by an SUV, not including that he was hit by his own partner and Detective of the CCSO - Mathews writes an email to Sheriff Burnett letting him know that he did it on purpose because he "didn't want to give them Carlos' name".

Mar 23, 2016: Detective Rodriguez reapplies to be a K9 handler, failing to disclose on that application that he was responsible for Reefer's death - merely stating that he graduated with his K9 Reefer and they were "certified as a team until his death in March 2016"

April 2, 2016: Sgt Rick Johnson is promoted to Chief of Patrol for the CCSO

April 5, 2016: Sheriff Burnett receives an email complaint from the public about the perceived intentional misleading of the public by Undersheriff Mathews

April 12, 2016: Jennifer Tyler received honorable mention for deputy of the year for 2015

May 17, 2016: Brian Burnett is added to a list of elected officials deemed "extremists" by the Southern Poverty Law Center

June 1, 2016: Sgt Harris returns to work - after reinstatement he was reportedly mistreated - they refused to issue him a weapon, gave him a poorly fitted protective vest, and assigned him faulty patrol vehicles

June 14, 2016: Sheriff Brian Burnett attends a protest of transgender YOUTH bathroom access and signs a petition against it IN UNIFORM AS SHERIFF OF CHELAN COUNTY, then addresses the school board and asks the board to consider the pledge of allegiance and the phrase "under God".

Dec 16, 2016: Deputy Harris receives the top overall traffic award at the Night of 1000 Stars ceremony

Feb 15, 2017: Musgrove given Beyond the Badge Award

April 11, 2017: Sgt Marcus "Mike" Harris files lawsuit for wrongful firing, retaliation, defamation and more after the retaliatory treatment got worse

Aug 3, 2017: Shepard was selected as a "Top Performer" for region 12 in the "click it or ticket" campaign

August 12, 2017: After the Unite the Right White Supremacist Rally was broken up in Charlottesville, Va because of clashes between white supremacists and counter protesters: a

man deliberately drives his Dodge Charger into a crowd of the anti-racist counter protesters, killing one 32-year-old woman and injuring more than 19 others.

Aug 30, 2017: Adam Musgrove promoted to Sergeant.

Sept 11, 2017: A Chelan County Sheriff employee (Who has yet to be officially named) shared a post from the Chelan County Emergency Management facebook page, generally reserved for emergencies information, with a picture of protesters being hit by a car with the tagline "All Lives Splatter, nobody cares about your protest, keep your add out of the road" - less than one month from the white supremacist Unite the Right Rally that ended in a counter protester being deliberately hit and killed by a car in Charlottesville, Va. This employee was not disciplined or fired.

Sept 17, 2017: Sheriff Burnett appears in a GCC Leo marriage retreat promotion video.

November 2017: Grace City Church holds marriage counseling for LEOs

Jan 2018: investigation launched into Tyler for "untruthfulness"

Mar 7, 2018: Tyler receives 500,000 award for retaliation and 450,000 for attorney fees: 950,000

Mar 8, 2018: Burnett talks about the 500,000 awarded to Tyler on KPQ - disagrees publicly with the decision

May 21, 2018: Grace City Church breaks ground on their nearly \$10 million dollar church project, advertising that it will be a "community center". It's to be noted, that even after finishing this nearly 10million dollar project, the assessed value of 277 Melody lane, the current location of the church is still - to this day - only \$149,000. They are paying less in property taxes than I am on my house even though the project was completed not long after breaking ground.

June 2018: Shepard is bullied in a messaging app for breaking his toe so badly they considered placing steel rods. An app that the CCSO is aware of and does not regulate though it is often used to communicate official business. The name of the chat group is "CCSO WPD SWAT"

Aug 2018: Tyler wins spot as a write-in on Ballot against Burnett during primary

Sept 4, 2018: Deputy Brian Lewis is hired

Oct 11, 2018: Tyler interviews about Sheriff campaign

Oct 2018: Tyler objects in a non-departmental email to other union members against Sgt. Adam Musgrove being nominated for union vice president: based on past harassment by Musgrove. Musgrove had already turned down the nomination before her email.

Nov 6, 2018: Tyler loses to Burnett by gaining only 35% of the vote

Nov 8, 2018: Undersheriff Mathews, still not on the Brady list, sends out an email to everyone in the department encouraging everyone to move forward together - and also that they take any complaints seriously.

Dec 2018: Tyler was placed on administrative leave after five complaints were levied against her by fellow deputies in the same week - two were sustained at that time all were rejected during arbitration.

Tyler Files second lawsuit against the county while on administrative leave for retaliation, discrimination, harassment and negligence in the workplace.

Feb 2019: Sheriff Burnett announces GCC head pastor Josh McPherson's son is "Chief for a day"

April 3, 2019: Shepard appears on Wake Up Wenatchee to promote an event as an official representative of the CCSO

April 25, 2019: GCC Pastor Josh McPherson's son is in the Apple Blossom parade for "Chief for a Day" through the CCSO

June 2019: Tyler was suspended for her comments about Musgrove

Aug 31 2019: Tyler was terminated again

Sept 2019: the deputy sheriff's association filed an unfair labor practice complaint against Chelan County - claiming the county discriminated against Tyler by disciplining her for her comments made during the union activity - which is separate from the CCSO

Sep 30, 2019: Corporal John Wisemore celebrates his retirement from the CCSO

Nov 1, 2019: Then deputy Brian Lewis tells Shepard to choke himself and provide a picture and receives multiple likes to the comment from his peers in the chat app.

Dec 2019: Then Deputy Brian Lewis makes borderline racist comments about a "burrito joint" that Shepard shared a picture of while he and his new wife were on their honeymoon. Also called Shepard a "treasonous douchebag".

Dec 2019: Shepard attended a SWAT training after returning from his honeymoon, only to be bullied by his peers and supervisors. Using his wife's maiden name as his in a derogatory manner. He was told prior to the firearms portion of the training that he was "going to fail the qualifications anyways."

Dec 2019: Shepard left that training after reporting the harassment and bullying to his superiors and nothing was done. He was later suspended from the SWAT team for an internal investigation while continuing to withstand harassment.

Jan 2020: Then Deputy Lewis is recognized for "overall traffic enforcement" at the 2019 Law Enforcement Traffic Safety Awards

Jan 29, 2020: Chelan County Commissioners uphold Burnett's decision to fire Tyler - Tyler moves the case to arbitration

After Feb 2020: Brian Lewis was promoted to sergeant less than 2 years after staring with the CCSO

Mar 2020: During a SWAT team overnight event, Sgt Brian Lewis grabbed and shoved Shepard when he could not clearly communicate to him. Shepard wrote that Lewis' "aggressive behavior was unprofessional" as that was Shepard's first explosive breach training and he couldn't understand what Lewis wanted him to do.

March-April 2020: Shepard speaks with then CCSO Sheriff's Chief of Patrol Rick Johnson about the incidents in December about the harassment and bullying while he was on leave during the investigation - nothing resulted from the conversation.

Mar 21, 2020: Then Deputy Brent Frank officially hired by CCSO after completing one year of probation soon after is promoted to Sergeant.

April 2020: Shepard wears sunglasses to a SWAT group meeting during an overnight training and was called "Elton John" by a peer and in front of the supervisors Lewis and Foreman. Foreman then said, "And it begins".

April 2020: Musgrove is promoted by Burnett to Chief of patrol to start July 1, 2020

April 10, 2020: CCSO Sheriff's Chief Rick Johnson is announced to become the East Wenatchee Chief of Police

May 2020: Burnett appears in a picture taken in the BPOE building owner by Jeff Kurpuis, with other local Far Right commissioners, council members, GCC Pastor and finance pastor, and GOP chairmen as they discuss suing Washington state Governor Jay Inslee over the mask mandate

May 13, 2020: Burnett and McPherson appear together as leaders interviewed by GCC attendee Dave Bernstein on The Agenda shared and promoted by the CCSO facebook page

May 24, 2020: GCC releases a video called "Is Patriotism Good for the World?"

May 29, 2020: Shepard publicly expresses frustration at a lack of training for some LEOs resulting in the excessive force that would end in the death of George Floyd, shaming Derek Chauvin and LEOs like him who are responsible for Floyd and other's deaths.

May 31, 2020: GCC releases video called: Jesus & Your Storm - where they talk about how sometimes obedience to Jesus will sometimes lead you into a storm because Satan is reigning over the world. "Jesus said: Hey you're gunna lose your life by the way, but it'll be better in the end" 30:30

June 2020: Guns are confirmed on security at Grace City Church where they advertise that half of their 25 armed "sheep dogs" are active duty local LEOs.

June 7, 2020: Wenatchee has a Black Lives Matter Protest where armed militia men stalk the protesters with large rifles strapped over their shoulders, some after the protest is over all the way back to their homes. Jeff Kurpuis and a few of his militiamen stood on top of the BPOE building and observe the protest at memorial park

June 24, 2020: Burnett says his agency won't enforce the mask mandate

Aug 23 2020: Pastor Carey McPherson from GCC texted parishioners and it was reposted by a local right wing teacher to an anti-masking facebook group. He wanted them all to show up to the August 24, 2020 Wenatchee School Board meeting directly misleading them and stating that there would be a discussion of "CRT, Comprehensive Sex Ed, and other experimental theory's on our children". He also states that he would be out of town or he would show up in "riot gear". Those topics were not listed on the agenda.

Aug 24, 2020: An unmasked crowd descends on the school board meeting, their refusal to mask, and one man's shouting aggressively while approaching the school board forced them to move to a remote meeting. Most of the unmasked misled attendees were Grace City Church patrons and followers of GCC.

September 2020: GCC released a pamphlet call "9 Critical Lenses to Help see covid more clearly" - encouraging people to continue to gather in large groups despite the state of emergency orders

Oct 25, 2020: GCC Releases a video called "When the State becomes God"

Nov 2020: Shepard answers a call of a COVID death, CCSO did not have a policy, even after 8 months of a world-wide pandemic and state of emergency in place, for how Deputies should handle a COVID death, as they were supposed to go in and document in writing and with pictures. He was advised by a colleague and the coroner not to go inside because it was a COVID death. He spoke to the supervisor Sgt Brent Frank, let him know what the others said, and Frank told him he needed to get pictures to investigate. When he arrived, other emergency services and paramedics made it clear they would not re-enter and gave him protective

equipment to obtain pictures. When he was finished and he reported back to Frank, he was orally reprimanded for going into the home to take the photos and the incident came up in his yearly evaluation.

Nov 22, 2020: GCC Releases a video called "Do not conform"

Jan 25, 2021: Chelan County Commissioners signed a contract with Grace City Church to provide "counseling" for the inmates of the Chelan County Regional Justice Center and Chelan County Juvenile Detention facility. According to the contract, "the Chelan County Regional Justice Center agrees to pay the sum of One-Thousand Three Hundred Dollars (\$1,300) per month for services rendered."

Feb 2021: Public Relations Employment Commission (PERC) ruled in favor of Tyler's dicrimination complaint - this was the conclusion of the decision in Jan 2020 where the Chelan County Commissioners upheld Burnett's decision to fire Tyler after she filed for arbitration

March 2021: Tyler begins receiving the money for a *separate* and previously undisclosed amount from the CCSO for her termination in 2019 and in exchange for her to not apply with the CCSO again. This was revealed later not in a lump sum but to be continued to be paid as if she were still working for the next 5 years including benefits.

March 2021: Grace City Church hosts Regional Law Enforcement Training for LEOs across the state where the church leaders handed out gift baskets that included gift cards on a drone video taken by WPD (Sample the drone video)

Sgt Brent Frank starts off the three day March 2021 training by going over a brief agenda for the weekend and then introducing GCC Pastor Josh McPherson for a pep-talk that included anti-government messaging. At this time, Pastor Josh McPherson also focused on the laws passed in the wake of the George Floyd Protests which are perceived by many LEOs to "hamstring" their ability to do their jobs. After he's finished with his anti-government propaganda speech he prays over the 50 plus attendees at which time Sgt Chris Foreman is loudly participating and crying.

Another GCC affiliated Wenatchee PD Officer Justin Kissel took the mic after the prayer and invited everyone to their church's men's group that would be meeting in the mornings before training started. Justin Kissel is now Grace City Church's head of security and no longer working for the Wenatchee PD.

May 30, 2021: GCC Releases a video called "Cultural Marxism & Critical Race Theory - How a toxic ideology is changing the world you live in"

June 2021: The last of 5 2 day trainings starting in February 2021 held at GCC: during one of the five training GCC Pastor Josh McPherson says he likes playing the "bad guy" for the

trainings - turns out he and other GCC civilians have been participating in the training in various roles.

July 4, 2021: GCC Releases video called "What to do when freedom is running on fumes"

July 5, 2021: Sgt Brian Lewis formally reprimands Shepard for allegedly "violating the civil rights" of a man he arrested - Shepard reached out to current candidate for court judge Allen Blackmon who, as the Chelan County Deputy Prosecuting Attorney, told him not to worry about it because he did not believe Shepard violated the rights of the suspect - District Court judge Kyle Mott found probable cause in the allegation and forwards the charges to the prosecutor's office.

July 8, 2021: State Employment commission ruled that Chelan County discriminated against Jennifer Tyler by wrongfully suspending her after she criticized a co-worker nominated for a union position meaning she could move forward with her lawsuit.

July 20, 2021: Burnett signs and publishes letter saying he will protect the second amendment

July 26, 2021: GCC releases a video called - Jesus says take off the mask

Aug 2021: Shepard was passed over for a position he applied for as a qualified "defensive training use of force instructor" with Sgt Lewis going so far as to write an official letter to the administration to prevent Shepard from even getting an interview.

After making a formal complaint to his union leaders about it, Undersheriff Jason Mathews emailed the leaders to confirm that Shepard was allowed to interview: so Shepard showed up in full uniform for the interview only to be turned away at the door saying the process had already been concluded.

Aug 2, 2021: Burnett hosts a Town Hall at GCC to inform local citizens and how "new legislation" will "impact" LEOs ability to protect the community - it was two hours of whining, fear mongering, misinformation, and anti-government rhetoric.

Aug 21, 2021: GCC starts offering religious exemptions for the COVID vaccine.

Aug 27, 2021: The U.S. Eastern District Court discrimination case regarding Jennifer Tyler was reported as scheduled for April 2022 - at some point it was petitioned to be moved to November 2022 after the Sheriff's Office Election.

Aug 29, 2021: Shepard submits a formal complaint stating that he had "exhausted all remedies by taking these issues to immediate supervisors" and using his chain of command. He specifically says in the complaint that he was subjected to harassment from Sgt Lewis, Foreman and other peers because he left Grace City Church and refused to shun Deputy Jennifer Tyler.

Shepard asked his union representative Detective Paul Nelson to file a grievance against the CCSO and Lewis.

Aug 31, 2021: Grace City Church releases their Permission to Protest video on YouTube - this same moth Grace City Church's founding and lead pastor, Josh McPherson, published a 72-page manifesto in August 2021 that lays out his role in a 2020 lawsuit involving "40+ individuals" who got together to "legally challenge our governor's overreaching powers" during the COVID-19 pandemic.

It's the first of three lengthy documents McPherson has authored pushing back against public health protocols and state mandates designed to limit the spread of a virus that has killed millions of people globally.

Sept 1, 2021: Sheriff Burnett pulls all resource officers from Cascade, Cashmere, Chelan, and Manson School Districts stating that the COVID vaccine requirement was an infringement of the deputies rights - even though COVID was reportedly the #1 cause of death for LEOs nationally.

Sept 15, 2021: Head GCC pastor Josh McPherson appears as a guest on the Christ Church podcast "CrossPolitic" out of Moscow, Idaho. McPherson came on the show to talk about his first Covid-era manifesto titled "We Do Not Consent." In it McPherson describes how he organized a group of more than 40 people to sue Washington State Governor Jay Inslee over Covid-19 mandates.

Christ Church, known colloquially to locals of Moscow as "Mother Kirk," is an extremist Calvinist sect led by Douglas Wilson. Wilson has received international attention for his defense of slavery. He has also dismissed the idea of marital rape. A man "can't trespass in his own garden," he infamously wrote on the topic. He has also gone to bat for sexual predators and is listed as a "guest lecturer" in Grace City Church's Vector Academy marketing booklet, which is how I first learned about him.

The same month of September 2021, Sheriff Brian Burnett shows up in a picture for GCC's "anchored youth" camp on Grace City church's website. This picture is important because they are all holding up a problematic symbol that has been linked with white supremacy, and as a Sheriff: he should have known that.

Nov 2021: Sgt Chris Foreman promoted to Chief of Special Operations at the CCSO

Nov 3, 2021: Burnett returns resource officers to schools.

Nov 8, 2021 Justin Kissel is featured in a Grace City Church video

Jan 2, 2022: Results of a 2020 survey of the "sworn personnel" of the CCSO were made public by a local investigative journalist - they reveal a deeply divided agency where half of the "sworn personnel" would not recommend working for the CCSO and that promotions go to members of

GCC over those who do not attend the church - and is a hostile work environment for anyone who does not attend GCC. (use pictures of the complaints - and read them) One person even stated that the "God Squad has a firm grip on what direction" the department is heading. Concerns over lack of integrity about people on the promotion list are repeated by many of the personnel.

Jan 6, 2022: Sgt Harris receives \$425,000 judgment against CCSO in a settlement for retaliation - he was also reinstated at the same rank and allowed him to retire effective November 1, 2021

Feb 22, 2022: The HR manager responded to Deputy Aaron Shepard's Aug 2021 harassment complaint stating no policies were violated but that it raised valid concerns on how members of the agency communicated with one another

Feb 28, 2022: GCC releases a video called - Jesus and Politics

Mar 10, 2022: CCSO facebook page makes fun of drug addiction by posting a picture of two people passed out in a vehicle

April 2022: Shepard leaves the CCSO and takes a position with Wenatchee PD - The Federal Trial against the CCSO for retaliation is moved to after the CCSO election to November.

April 17, 2022: GCC Baptizes a child without their parents consent, and without the child's understanding of what was happening. They also gathered the child's contact information.

May 2022: It's reported that Sheriff Burnett went and spoke in uniform at GCC's unaccredited vector academy, where they like to use the "right kind of indoctrination" to teach about the bible

The same month Deputy Mike Morrison, files to run against Sheriff Burnett in the 2022 election.

June 7, 2022: Regional Law Enforcement Training is held at Grace City Church again

June 17-19, 2022: GCC Holds their stronger man conference and Vector Academy graduation

June 29, 2022: Capt Reinfeld of the Wenatchee PD holds a "situational awareness" training for the chamber of commerce and downtown business owners - uses a lot of anti-government and anti-Olympia rhetoric and encourages the business owners to "Vote Different" implying they should vote Republican in order to deal with the "homelessness and drug situation" saying the laws passed by "Olympia" have "hamstrung" the department and if he were to find a "ball of heroin" on someone he would "have to let them walk" - directly misleading the public as to the requirements for drug encounters

July 3, 2022: Former Deputy Aaron Shepard came forward to disclose his experience of being bullied for leaving Grace City Church and refusing to ostracize Jennifer Tyler for her 2017 lawsuit.

July 15, 2022: Sheriff Burnett begins releasing a series of propaganda videos produced by Killing Robots LLC, one of the owners of which was on staff at GCC for their in-house videography.

Aug 28, 2022: Dominick Bonny revealed through a FOIA that because of an outside settlement, Tyler was still on the payroll and receiving benefits though she no longer was working for the CCSO and would be for the next 5 years.

Sept 6, 2022: Deputy Seabright makes a phone call to follow-up on a trespassing complaint of a Chelan County Resident and rants to the caller about the new laws handed down by "Olympia" regarding drugs and "homeless people". Seabright continued using a lot of overall anti-government language stating that if he found someone with a "ball of heroin" he would have to let them walk and encouraged this citizen to "vote different" which they took to mean vote for Republicans. It is to be noted that no drugs were referenced during the trespassing complaint and the perpetrator was assumed to be homeless - but no drugs were involved.

Sept 16-17, 2022: Sheriff Burnett attends the "ReAwaken America Tour" that featured alt-right extremist speakers like Matt Shea and others who promote the conspiracy that the 2020 election was fraudulent though there has been zero proof. Burnett also consented to be interviewed by Matt Shea for his podcast that uses terminology like "PedoHilter" in reference to the current President of the United States: Joe Biden.

Sept 18, 2022: Burnett's campaign released a post on Facebook asking "Did you catch us at Fiesta Mexicana (Wenatchee)" and included a stock picture of a traditional Mexican dancing girl, an 11 year old picture from the Wenatchee World, and also an unironic quote from the Christain Bible calling those who justify wicked actions and condemn the just abominations.

Tyler - 500,000+450,000+450,000 + benefits? Harris 425,000 settlement - 2 million dollars of tax payer money lost in wrongful termination, retaliation, and harassment law suits/settlements in the last 5 years.
